Newsletter: secretaryonelm@sbcglobal.net Sometimes a single image has a way of opening up new worlds for us. A couple of years ago, this image did that for me. I found myself thinking about the stillness after Jesus' birth. After the shepherds had gone home,



after the angel choirs, after the adrenaline wore off - what do you suppose it was like in those quiet hours? I love this depiction of Joseph as a father who is involved in caring for Jesus.

For as important that Joseph was in the story of Christmas, we know very little about him. Matthew and Mark talk about Jesus as the son of a carpenter or tradesman, but that's about all we get in terms of things that would usually land in a person's biography. But what we get instead are examples of how Joseph acted in difficult circumstances. And if we are trying to get to know someone, that might actually be more useful than knowing what they did for a living.

The Christmas story starts out with Mary engaged to Joseph. She's found to be pregnant but Joseph knows that he isn't the father. Scripture tells us that he's a righteous man. He would have been within his rights according to the laws of the time to have Mary publicly executed for adultery. But when God speaks to him through an angel he determines to stay with her and to raise the child she's carrying. It is hard for us to imagine the kind of social stigma that would have come with a decision like that. But it shows us something about his character: Joseph is someone who is willing to pursue God's path of love and mercy even when it isn't easy or popular.

The other glimpse that we have into who Joseph is comes from when, after the guidance of an angel, Joseph takes Mary and Jesus and flees to Egypt to avoid the wrath of Herod. In a society where your social and economic life are tied up in your family bonds fleeing to a different country would be like hitting the reset button on your life. Ask anyone who has fled from persecution or violence in their homeland, starting over in a new place is incredibly difficult. What this shows us about Joseph's character is that he's willing to do difficult things for the safety and well-being a very young child and his post-partum mother.

So this year, as you look at the nativity scenes around your home, at church, or out in the community. I invite you to take a few moments to linger over Joseph - a man who pursued God's path of love and mercy without regard for the social consequences and who will do difficult things for the wellbeing of the vulnerable people that God has placed in his life.


